Best Bred by Exhibitor

Best Bred by Exhibitor will be selected from the Bred by Exhibitors class winners following the judging of Best of Breed and Award of Merit competition. Only dogs not defeated in Bred by Exhibitor classes are eligible to compete.

Non Regular Classes Involving Single Dog Entries

Veteran Dog: for dogs at least 7 years of age (same class for bitches). Spayed bitches and neutered dogs eligible for Veterans Class.

Field Trial Dog: for dogs that have placed in an AKC Licensed or Member Field Trial or who have been awarded an AKC Hunting Test Title or who have been awarded a WCA Field or Water Rating prior to the closing date of this Show. (Same class for bitches).

Versatile Dog: for dogs who have been awarded a Versatile Rating from the WCA prior to the closing date of this Show. (Same class for bitches).

Best of Breed Competition

Those dogs and bitches, excluding BOB and BOS, who have made the judge's final cut remain in the ring for the WCA Award of Merit. The judge may choose up to six to receive the award. Those receiving the award will not be ranked nor chosen on the basis of sex. All awards to be made at the discretion of the judge.

Non Regular Classes Involving Multiple Dog Entries

Stud Dog: for Stud Dogs and two of their Get. Stud Dog must be entered in the Stud Dog Class and must be shown in the ring with their Get. Get only to be judged based on the merits of the Get. Get must be entered in a Regular Class, Best of Breed or some Non-Regular Class other than Stud Dog Class.

Brood Bitch: substitute Brood Bitch for Stud Dog and Progeny for Get.

As the Judge's decision in the Stud Dog & Brood Bitch classes will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won this class.

OBEDIENCE TRIAL CLASSES

Please Note: January 1, 2009 Obedience Regulations, Chapter 1, Section 3, Jump Heights required with entry. Include Jump Height on entry form with class. Entries without Jump Height will be judged at the end of the class.

From the 495 Capital Beltway: From I495, take I270 North. In Frederick, MD, I270 becomes Rt 40 North for a short distance, then turns into US-15 North. Continue on US-15 North for about 30 miles, and exit onto US-15 Business North. You will pass the Eisenhower Inn after 2 miles, continue following directions from the Eisenhower Inn below.

TRACKING REGULATION CAUTIONARY DISCLAIMER

No dogs are to be allowed to be "off lead" - due to the changing nature of the fields being used by clubs for tracking tests and the increased population at these sites by the general public, dogs shall be "on lead" at all times on any area of the tracking site.

NOTICE TO EXHIBITORS

Entries. The Tracking Test is for dogs not less than six months old. Dogs who have NOT passed a 'Tracking Test' must file with the entry, an original Certification Statement, dated within 12 months and signed by a person who is accredited by the AKC to judge a 'Tracking Test', that the dog is considered by the judge to be ready for such a test. An exhibitor may enter more than one dog. Entries without a TD or TDX title will be given preference for each test. Note: If the limit for entries is not reached in one test and the limit is exceeded in the other test, the number of tracks will be exchanged up to the limit set by the AKC Tracking Regulations. Owners are responsible for errors in making out the entry forms. No entry fee will be refunded, in the event of such errors or cancellation of entries after the published closing date other than those provision outlined below.

Draw For Entries will be drawn at the home of the Test Secretary, 407 Greenlow Road on Friday, April 16, 2010 at 7:00 p.m. The drawing shall be completely at random among all entries received, except that preference shall be given to Weimaraner dogs which have not previously earned a tracking or tracking dog excellent title. If the limit in any of the tests is not reached in

Weimaraners, other breeds may enter using the following procedure: Draw (1) Weimaraners without a title; Draw (2) Weimaraners with a title; Draw (3) Other breeds without a title; Draw (4) Other breeds with a title. When the advertised limit has been drawn, all remaining entries shall be assigned a position on the alternate lists corresponding to the order in which they were drawn. The Secretary shall then notify all entries of the results of the draw.

Entry fees include \$0.50 AKC recording fee and \$3.00 event service fee.

Mail all entries with fees to : Nick Ambulos, 407 Greenlow Rd., Catonsville, MD 21228. Entries not on official AKC entry forms & photocopies of entry forms without the Agreement and Rules on the reverse side of the official AKC entry form are not acceptable. Checks to be made payable to the 'WCA'. Telephone, Telegraphed, unsigned, or entries without fees or certification statements (if applicable) cannot be accepted. Returned checks do not constitute a valid entry fee and will have to be made good with cash or money order prior to showing. The Test Secretary will add a collection fee to the amount of each returned check. Overnight delivery service must include a signature release.

Refunds. Entry fees will be refunded for an alternate who does not participate in the event within fourteen (14) days of the test date. In the event an accepted entry cancels prior to the closing date to allow an Alternate to replace said entry, **the entry fee will be refunded.** In the event an accepted entry withdraws after the closing date and there is no Alternate to replace said entry, **the entry fee will not be refunded.**

The Eastern Section of the Weimaraner Club of America's 2010 Show Futurity will be judged at this show. All dogs/bitches entered in the Futurity must be entered in one of the regular or non-regular conformation classes of the WCA National Specialty Show on Thursday & Friday, May 20-21, 2010. A \$20.00 entry fee is required to enter the Futurity after the dog/bitch has been properly entered in one of the regular or non-regular conformation classes.

Division of entry money as prizes: 50% of all moneys paid into the Futurity Program retained by the Weimaraner Club of America for expenses. The purse will be divided on a sectional basis reflecting the total number of dogs/bitches in competition. After the monies for each show sectional have been computed, the division shall continue as follows: 1/7th each to the Winners (First place in each of the classes: Senior, Intermediate, Junior - dogs & bitches) 1/14th (additional) to Best Dog in Futurity and to Best Bitch in Futurity. Each winner's share will be divided further and paid in this manner: 60% to Owner, 40% to Breeder. Notice: All entries must comply with the rules governing the WCA's Show Futurity. Exhibitor is solely responsible for knowledge of and compliance with those rules.

Classification

Senior Dog/Bitch - Born on or after June 1, 2008 through September 30, 2008

Intermediate Dog/Bitch - Born on or after October 1, 2008 through January 31, 2009

Junior Dog/Bitch - Born on or after February 1, 2009 through May 31, 2009

The order of judging will be: Junior Dog, Intermediate Dog, Senior Dog, Best Dog in Futurity. Junior Bitch, Intermediate Bitch, Senior Bitch, Best Bitch in Futurity. After the judging of Best Bitch in Futurity, the Best Dog and Best Bitch will enter the ring together with no further judging to take place. Both Winners will share equally in the honors and awards.

WEIMARANER CLUB OF AMERICA
EASTERN MATURITY

The Eastern Section of the Weimaraner Club of America's 2010 Show Maturity will be judged at this show. All dogs/bitches entered in the Maturity must have been eligible for a Sectional Show Futurity and must be entered in one of the regular or non-regular conformation classes of the WCA's National Specialty Show on Thursday & Friday, May 20-21, 2010. A \$30.00 entry fee is required to enter the Maturity after the dog/bitch has been properly entered in one of the Specialty Classes.

Division of entry money as prizes: The monies collected from the initial litter registration forfeits, as well as late penalty fees will be considered the Breeder's contribution. 50% of the Breeder's contribution will be retained by the Weimaraner Club of America for expenses. 1/4 of the total remainder of the Breeder's contribution will be joined to the entry fees collected at each Sectional Maturity to be awarded to the owners of the four placements in dogs and bitches. The available monies will be divided 1/2 for dogs and 1/2 for bitches in this manner: 40% to first, 30% to second, 20% to third and 10% to fourth. Notice: All entries must comply with the rules governing the WCA's Show Maturity. Exhibitor is solely responsible for knowledge of and compliance with those rules.

Classification

Maturity Dog/Bitch - Born on or after June 1, 2007 through May 31, 2008

Classes will be divided by sex only.

Placement will be first, second, third and fourth. First place dog will be Best Dog in Maturity. First place bitch will be Best Bitch in Maturity. After the judging of Dogs and Bitches is complete, the Best Dog and Best Bitch will enter the ring together with no further judging to take place. Both Winners will share equally in the honors and awards.

- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to AKC. (For complete rules, refer to Chapter 11, Section 3).
- Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "MIXED BREED." Variety, Breeder, Sire, Dam information shall remain blank for mixed breed entrants.
