**Non Regular Classes Involving Single Dog Entries**

**Veteran Dog:** for dogs at least 7 years of age (same class for bitches). Spayed bitches and neutered dogs eligible for Veterans Class.

**Field Trial Dog:** for dogs that have placed in an AKC Licensed or Member Field Trial or who have been awarded an AKC Hunting Test Title or who have been awarded a WCA Field or Water Rating prior to the closing date of this Show. (Same class for bitches).

**Versatile Dog:** for dogs who have been awarded a Versatile Rating from the WCA prior to the closing date of this Show. (Same class for bitches).

**Best of Breed Competition**

**Awards of Merit:** The specialty Judge may at his/her discretion award Judge's Awards of Merit to a maximum of 10% of the Best of Breed entry, plus Winners Dog and Winners Bitch, along with the Winners of the Veteran, Field Trial and Versatile Classes.

**Best Puppy:** During the course of judging regular classes, the specialty judge will select a Best Puppy from the class winners of the six to nine month and nine to twelve month classes. This will be done after the Best of Breed judging unless the Best Puppy award is automatic. Example: An entry from the puppy classes is awarded Best of Winners or Best of Breed. Only dogs or bitches undefeated in a puppy class are eligible for Best Puppy Competition. If the first place winner is not present, the second place winner may not compete. There is no additional entry fee for this competition.

**Best Bred-by-Exhibitor:** During the course of judging regular classes, the specialty judge will select a Best Bred-by-Exhibitor from the Bred-by-Exhibitor class winners. This will be done after the Best of Breed judging unless the Best Bred-by-Exhibitor award is automatic. Example: An entry from the Bred-by-Exhibitor class is awarded Best of Winners or Best of Breed. Only the dog and bitch undefeated in a bred-by-exhibitor classes are eligible for Best Bred-by-Exhibitor Competition. If the first place winner is not present, the second place winner may not compete. There is no additional entry fee for this competition.

#### Non Regular Classes Involving Multiple Dog Entries

**Stud Dog:** for Stud Dogs and two of their Get. Stud Dog must be entered in the Stud Dog Class and must be shown in the ring with their Get. Get only to be judged based on the merits of the Get. Get must be entered in a Regular Class, Best of Breed or some Non-Regular Class other than Stud Dog Class.

**Brood Bitch:** substitute Brood Bitch for Stud Dog and Progency for Get.

As the Judge's decision in the Stud Dog & Brood Bitch classes will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won this class.

#### OBEDIENCE TRIAL CLASSES

Please Note: January 1, 2009 Obedience Regulations, Chapter 1, Section 3, Jump Heights required with entry. Include Jump Height on entry form with class. Entries without Jump Height will be judged at the end of the class.

**OPEN JUNIOR CLASS:** For boys and girls who are at least 9 years and under 12 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

**OPEN INTERMEDIATE CLASS:** For boys and girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

**OPEN SENIOR CLASS:** For boys and girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

**BEST JUNIOR HANDLER:** A club offering Junior Showmanship may offer a prize for Best Junior. The prize must be described in the premium list in accordance with Rules Applying to Dog Shows, Chapter 5, Section 4. The Junior Handler placed first in each of the regular Junior Showmanship Classes, if undefeated in any other Junior Showmanship Class at that show, shall automatically be eligible to compete for this prize.

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering i.e., Cocker Spaniel (solid color black, ASCOB, parti-color). Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to AKC. (For complete rules, refer to Chapter 11, Section 3).
- Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "MIXED BREED." Variety, Breeder, Sire, Dam information shall remain blank for mixed breed entrants.

Entries received without fees will not be accepted. Acknowledgement of entries will be made as soon as practicable after closing via mail.

Fax Machine entries for this show will be accepted up to closing time (EST). Both sides of entry form must be submitted. For Visa/Mastercard card holders ONLY. A \$4.00 charge will be added to each entry. Be sure to include the cardholders name, address, card number, expiration date & signature. If the credit card charge is denied for any reason, an additional service charge may be added. Fax number: (561) 784-6789. This is for faxed entries only. Incomplete or illegible FAX entries are not acceptable as a valid entry in a show. Proof of transmission is not proof of receipt of a legible or complete transmission (under AKC Rule Chapter 11, Section 4).

CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS.

RETURNED CHECKS / INVALID CREDIT CARDS do not constitute a valid entry. The Club will add a collection fee of \$25 to the amount of each returned check and credit card.

Entry fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or judge, or barred from competition by action of the Show Committee.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club or the Show Secretary.

**No Refund for Duplicate Entries.** Every effort to find all duplicate entries will be made; however, if entry has been processed, no refund will be made.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance.

Changes, additions or corrections to entry forms must be received in writing or e-mail prior to close of entries. Those received by telephone are not acceptable.

OWNERS ARE RESPONSIBLE for errors in entry forms, regardless of who may make such errors.

Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Neither the Club nor its Show Secretary will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. **Owners or agents alone are responsible for the presence of their dogs in the judging rings.**

The show giving Club, the Show Secretary, their agents, employees, etc. assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assume no responsibility for injury to children.

WCWCDA reserves the right to substitute a prize of equal or greater value.

All trophies must be claimed the day of the show. None will be mailed.
